# **Product Disclosure Statement updates**

## 4 December 2023 - Fees and Costs update

Sandhurst has undertaken an annual review of the fees and costs in relation to the Fund's financial year ended 30 June 2023 and wishes to update the fees and costs disclosed in the PDS.

The below updates are made to the PDS.

Transaction costs  The costs incurred by the scheme when buying or selling assets	0.02% p.a.	Transaction costs incurred by the Fund are paid as and when they are incurred by a deduction from the Fund, and transaction costs incurred by an interposed vehicle in which the Fund has invested are paid by that interposed vehicle. In each case, these transaction costs are reflected in the Fund's unit price.

- Under the 'Performance fees' section, the second paragraph is deleted and replaced with:
  - "Accordingly, the total performance fees set out in the 'Fees and costs summary' include performance fees chargeable by us (nil) and performance fees of 0.23% p.a. chargeable by some of the asset managers of interposed vehicles in which the Fund invests."
- Under the 'Transaction costs' section, the third sentence is deleted and replaced with:

"The amount of total gross transaction costs is 0.11% p.a."
